am Mr. Debanda Turubudi who was a plumber used to earn hardly Rs. 3000/4000 per month from my occupation and it was much difficult to take care of my family being 5 members including my wife, father and mother at Ramnaguda villages under Rayagada district of Odisha. I am not even able to serve 3 square of meal, children education expenses and other basic amenities with my earning.

Mean while in the year 2017 I came into contact with the one of the staff of "READ" organization and came to know about the farmers group. Instantly join with farmers group and day by day started attending the trainings and workshop regarding IGA and agriculture well. Frequently I was in contact with Livelihood Resource Persons designed and prompted by the "READ" and got handholding support which helped me to get ideas of agricultural practice. In 2019 on behalf of "READ" organization I have got Rs. 10,000/- rupees for land leveling and I just converted my uncultivable land into cultivable land. Then gradually I started cultivating different type of farming such as: paddy, pulses & vegetable seasonally. I have been also supported 9 different seeds by READ in the COVID-19 pandemic last year as well as 15 days ration & sanitary kit.

I am very happy to see my land covered with different grain as well as from this one acre of land I have generated Rs.40, 000/- profit last year from paddy & vegetable cultivation. This year also I have cultivated paddy and vegetable in my land and wishing to increase the profit price well. So all I want to say that an ordinary person like me can touch this level of success then why not other people in my locality?

So at last I just want covey my hearty thanks and gratitude to "READ" Organization and the staff for all my life changing towards happiness.
